

Complete two-factor authentication.


Undergo face verification for secure access.

Attach diagnostic reports, images, and lab results.




Use voice-to-text or manually enter notes

Open the patient profile and click Create E-Prescription.




Select medications, dosage, and duration.




Add special instructions if necessary.
